### POINT 2 - FLOOD OF UNSKILLED IMMIGRANT LABOUR – HIDDEN FROM US

Dear Union Secretary and Union Boss,

The way to gain the support of Australian workers, and reinstate unions as a power in Australian society, is to be seen to stand up and fight against corporate corruption and the abuse of the workforce. Be the good guys and do it for Australia as a nation.

The first step, the first huge step, to rally national support for unions, would to be seen to fight for the rights of all Australian workers. Not just your own group and your own members. Call it a public relations exercise. "With the big national issues stand and fight for the rights of all workers." That then includes your own members.

**POINT 1** - What I have is clear evidence of corporate corruption, and abuse of the workforce, outlined in the letters to ICAC and Senator the Hon Michaelia Cash - Minister responsible for the Fair Work Commission at this web address: [www.hootgallery.com](http://www.hootgallery.com) Heading: Social Conscience

The Fair Work Commission (FWC) was set up by Labour leader Kevin Rudd to do what the name implies – Be fair to workers and protect workers' rights. It has been overrun and corrupted by corporates at the expense of Australian workers. I have evidence of that corruption, on the court record. There is an opportunity here to rally national union support – Think about it...

The way the world works is that corporations lobby politicians for legislation that favours corporates and corporations donate to election funds in return for favours. We can't let those favours include corrupting our government, corrupting our law and abuse of the Australian workforce.

Read the letters I have sent to Senator Cash and make up your own mind. March on the FWC and accuse them of corruption and demand justice for Australian workers. Make a big deal of it – You are fighting for the rights of all Australians against corporate corruption. That's the corporate corruption of our elected representatives and our career public servants to the detriment of the workers.

The idea is to be seen to be protecting the government from corporate corruption. Don't attack the government we need to protect the government. Corporate corruption is the problem and it must be exposed.

It took a lot of planning and management to expose what has been going on in the Fair Work Commission, with evidence to back it up. I fight hard for what's right and in particular for the rights of Australian workers – The same thing you fight for... The difference is, I do it for free and, I don't give up. With evidence of corporate corruption in the FWC, what I have handed unions is leverage – Use it! Fight for the rights of workers and demand better wages and conditions. The top end of town has had their fill – Now it's the workers turn.

**POINT 2** - The second problem is outlined in the letter to The Hon Peter Dutton MP Minister for Immigration and Border Protection. Unskilled immigrant labourers, disguised as students, are being brought into the country to the detriment of Australian workers. This aspect of immigration has been hidden from us and one needs to ask why?

If unions are seen to support this what does that do for union credibility? What do Australian workers think about unions who screw them? I'll tell you what they think - They think the same thing Australian society thinks when they are threatened and held to ransom. The school-yard bully tactics, used by unscrupulous corporations, don't work in a civilised society. They have the opposite effect – It creates resentment and animosity.

Read the letter to Peter Dutton and push him for a reply. In the process, find out who's making all the money out of this lovely little immigration scam. To gain strength, you don't want to be seen to be screwing the Australian workforce and their families. Just like in America, stop the flood of unskilled labour coming into the country. Handled the right way unions can come out of this looking fantastic – A pillar of society.
